## History at a Glance

---

### 1969

On January 2, 1969, John Lowndes and three of his partners from another local law firm opened the doors of Lowndes, Peirsol, Drosdick & Baker on the 4th floor of the First Federal Savings & Loan Association building on the corner of Magnolia & Church Street in downtown Orlando. Six months later, William E. "Bill" Doster becomes the first lateral to join the firm.

The headlines in 1969 reflected a range of historic events from the first Concorde test flight to the first man to walk on the moon. Frank Sinatra's hit single *My Way* topped the music charts while the Woodstock Music Festival attracted more than a half million people over four days in upstate New York.

### 1972

Hal Kantor joins Lowndes, Peirsol, Drosdick, Baker & Doster and later becomes a name partner. Bill Baker left to become a real estate developer, and Fred Peirsol left to pursue his fortune elsewhere.

---

### 1980

Lowndes, Drosdick, Doster & Kantor moves into its newly constructed French classical building overlooking Lake Eola. Two years later, sadly, Ernie Drosdick dies suddenly.

---

### 1984

John A. Reed joins the firm after stepping down from the federal bench where he served as U.S. District Court Judge for the Middle District of Florida since his appointment by Richard Nixon in 1973. The firm changes its name to Lowndes, Drosdick, Doster, Kantor & Reed.

---

### 1996

The firm builds the Lowndes Conference Center and additional offices.

---

### 1997

Nicholas A. "Nick" Pope succeeds John Lowndes as Managing Partner.

---

### 2000

The firm opens its second office in the CNL Tower in downtown Orlando.

---

### 2008

William T. "Bill" Dymond, Jr. succeeds Nick Pope as President, CEO and Managing Partner.

---

### 2014

The firm expands its footprint to the Space Coast, opening an office in Melbourne. Later that same year, the firm expands into Lake County, combining with Mount Dora-based Potter Clement Bergholtz Alexander.

### 2018

Lowndes, Drosdick, Doster, Kantor & Reed, P.A. rebrands as Lowndes

---

### 2021

Firm founder John F. Lowndes passes away in February. Three months later name partner William E. Doster passes away.
