The organization, which serves as the state's aerospace and spaceport development authority, has partnered with NASA to operate Kennedy Space Center and expanded the state's ability to dominate the growing commercial space market while creating jobs in this unique sector. He is also the Chair-Elect of the Orlando Economic Partnership (OEP) Executive Committee for the 2018-2019 term. Having previously served on the OEP's Executive Committee and Board of Directors, Dymond also chairs the organization's Business Development Strategy Committee and was formerly the Co-Chair of the Investor Relations and Business Development Committee. Dymond is a long-time supporter of civic and charitable organizations and has served as a board and executive committee member of Enterprise Florida which promotes economic development statewide and was recently invited to join The Florida Council of 100.
